SECTON 4 - Credit Terms (please read carefully)

- 1. All accounts are due and payable on or before the 25th of the month following the date of purchase/serivce or such other cutoff date as Whitecourt Transport Inc may choose.
- Interest will be charge on overdue accounts at the rate of 2% per month (26.82% per annum) calculated and compounded as simple monthly interest accruing daily from the time it first accrues until payment is made notwithstanding any judgment or attachment.
- 3. The credit applicant shall be responsible for the full amount of all proper and reasonable costs, expenses and fees incurred by Whitecourt Transport Inc to effect collection of overdue accounts for solicitor's or agent's services, on a solicitor and client basis and such with respect to accrual of interest
- 4. The credit applicant acknowledges and agrees that:
 - a. All employees or representatives of the credit applicant have authority to purchase, on behalf of the credit applicant, any goods or services from Whitecourt Transport Inc.
 - b. The signature of any employee or representative on any Whitecourt Transport Inc pro bill, invoice or work order is sufficient to acknowledge indebtedness of the credit applicant to Whitecourt Transport Inc for the amount shown on the pro bill, invoice or work order; and
 - c. Whitecourt Transport Inc. shall be expressly authorized to file a garage man's lien on any vehicle in respect of which Whitecourt Transport Inc has supplied goods, or on which Whitecourt Transport Inc. has performed work.

SECTION 5 - Privacy Terms

Collection of Information
